I, the undersigned, in consideration of my participation in the Camp(s) referenced above and related activities thereto including training, preparation, and travel (separately and collectively, the “Camp”), wherever the/these Camp(s) may occur, acknowledge that I am aware that due to participation in the Camp, there exists the potential for injuries and accidents, including but not limited to strains, sprains, scrapes, bruises, broken bones, concussions, and various injuries to the body, and I freely assume all risks incidental to such participation.

In consideration of my participation in the Camp and on my own behalf, and on behalf of my heirs, executors, administrators and next of kin, I hereby release, covenant not to sue, and forever discharge the Released Parties (as defined below) of and from all liabilities, claims, actions, damages, costs and expenses of any nature arising out of, related to, or in any way connected with my participation in the Camp and/or any such related and associated activities, and further agree to indemnify and hold each of the Released Parties harmless from and against any and all such liabilities, claims, actions, damages, costs and expenses including by way of example, but not limited to, all attorneys’ fees, costs of court, and the costs and expenses of other professionals and disbursements up through and including any appeal. I, for myself, understand that this Release and Indemnity includes any claims based on the negligence, action or inaction of any of the Released Parties and covers bodily injury, property damage, and loss by theft or otherwise, suffered by me either before, during or after such participation. I declare that I am physically fit and have the skill level required to participate in the Camp and/or any such related and associated activities. I further authorize medical treatment for me, at my cost, if the need arises.
